Payments

Most payments can be made by phone. **Bond** and **purge payments** can be made by phone, as long as we can locate the signed court order in our computer system (JIMS).

CHILD SUPPORT PAYMENTS

Regular State of Tennessee IVD Child Support payments **CANNOT** be made at the Juvenile Court Clerk's Office per Tennessee Code Annotated § 36-5-611. You can call the TN Child Support Office at 615.726.0530 for payment options or visit their website.

Contempt payments: We can only accept payment **IF** someone is **in contempt** of paying their child support **AND** they have a **signed court order** specifically stating to "purge or make payment at the Juvenile Court Clerk's (JCC) office." **Please have the court order with you when making these payments.**

ACCEPTABLE FORMS OF PAYMENT

ALL acceptable forms of payments can be made at our Payment Counter at the Juvenile Court Clerk's Office

We are on the lower level of the Juvenile Justice Center
(next to the Titan's Stadium).

A Court Order, Invoice, File, Petition, or Decree number will be needed.

Cash Payments

Cash can only be accepted at our Payment Window. **Do Not Mail.**

Debit/Credit Card Payments

Most "Tap to Pay" cards can be used at register.

- \$2 fee for transactions up to \$83.50
- Transactions over \$83.50 will be charged 2.4%
- Max of \$4880 can be charged per card per day
